
TENKOFX CAMPAIGN TERMS

«INVITE YOUR FRIEND, GET \$10
AND WIN \$5,000»

TERMS AND CONDITIONS OF THE CAMPAIGN:**1. GENERAL PROVISIONS**

1.1. These terms and conditions set forth the procedure for the "Invite your friend, get \$10 and win \$5,000" promotion campaign.

1.2. The campaign is organized by TenkoFX Limited.

1.3. Every client of TenkoFX Limited may take part in the campaign.

1.4. Every participant in the campaign is guaranteed a \$10 bonus for every client they attract.

1.5. Every participant in the campaign automatically takes part in the TenkoFX Agent partner program, which provides an additional source of income based on a share of the spread on each transaction made by the attracted client.

1.6. Total prize money is \$60,000. The draw will be held in four rounds, each of which has a total prize money of \$15,000 and will last for three months.

1.7. The promotion campaign will officially launch on February 1, 2014.

1.8. During the campaign, all registered participants will have the opportunity to take part in the following prize draw:

- 1st prize - \$5,000
- 2nd prize - \$3,000
- 3rd prize - \$2,000
- 4th prize - \$1,000
- 5th prize - \$950
- 6th prize - \$850
- 7th prize - \$750
- 8th prize - \$650
- 9th prize - \$550
- 10th prize - \$250

1.9. An extra prize draw will be held on December 31, 2015 as part of the "Invite a friend, get \$10 and win \$5,000" campaign. Its budget is \$40,000. 40 winners will be randomly selected, and each of whom will get a prize of \$1,000.

1.10. By agreeing to the terms and conditions of the campaign, you agree to receive special offers from TenkoFX.

2. CAMPAIGN PARTICIPANTS

2.1. Only users above 18 years old that have been registered on www.tenkofx.com may participate in the campaign.

2.2. To take part in the campaign, you must attract at least one client through your referral link (found in the Promotional Materials section of your TenkoDESK workspace). The client you attract cannot be an existing client of TenkoFX. Verification of the new client's TenkoDESK account and a trading volume of least 2 lots is a mandatory qualification condition.

2.3. You can also join this campaign by posting links to your social network accounts and joining one of the TenkoFX social groups on Google+, Facebook, LinkedIn and Twitter. Active participants posting links and joining groups also get extra preferences: your TenkoFX customer account number (TenkoDESK #) will be included in the prize draw, improving your chances of winning. To learn more, send a request to promotions@tenkofx.com. In your email, you should include:

- The subject header "Invite your friend, get \$10 and win \$5,000" campaign.
- A link to your post containing the link to the campaign and the TenkoFX social network group you have joined.
- Your personal TenkoDESK number.

2.4. To take part in the \$40,000 bonus draw, you must attract at least 30 clients in accordance with the terms in 2.2 above.

3. CAMPAIGN RULES. RIGHTS AND OBLIGATIONS OF PARTICIPANTS

3.1. As a participant of the "Invite a friend, get \$10 and win \$5,000" campaign you will receive \$10 into your TenkoFX Money Box for every client you attract according to the terms in 2.2 above. This money can be withdrawn without restrictions. A maximum amount of \$500 per month (50 clients) can be paid for clients attracted under this promotion. To withdraw the funds you must have a verified TenkoDESK account.

3.2. As a participant in this campaign you automatically take part in the TenkoFX Agent partner program, giving you the opportunity to earn additional income as portion of the bid/offer spread on each transaction made by the clients you attract, even after the campaign has ended. This is a source of a long term revenue for you as a TenkoFX Agent partner.

3.3. Register as campaign participant on the www.tenkofx.com website (www.tenkofx.com/en/partners/promotions/)

3.4. The winners will be determined by a draw from the TenkoDESK numbers of all the clients who have been attracted under the terms of the campaign. This means that more clients you attract, the higher your chances are of winning a prize.

3.5. If the you register under the terms of 2.3 above, or complies with the campaign as an active participant, then your personal TenkoDESK number will also eligible for the draw, giving you an additional chance to win.

3.6. To be eligible for the draw your TenkoDESK account must be verified prior to the launch of the draw.

3.7. If the administration finds any violation of the terms in 2.3 above, for example the removal of your link to the campaign or your leaving the TenkoFX social group, your participation in the campaign will be terminated.

3.8. If you win prize you will not participate in any further draws - however you will be eligible for the end of year bonus draw (December 31, 2015) if you comply with the terms in 2.4 above.

3.9. The minimum number of active participants required for the next level of promotion is 200. If there are not enough participants, the current stage will be prolonged.

3.10. TenkoFX does not act as a tax agent to any of the participants in this campaign. You will be responsible for all taxes, including personal income tax, which you are required to pay on winnings according to the law applicable in your home country.

4. WINNER SELECTION PROCESS

4.1. The winner of the campaign will be selected randomly on www.tenkofx.com.

4.2. All registered participants will be divided into six equal groups. Then one group will be selected by rolling a six-sided dice. This winning group will be divided into a further six groups with random selection, and so on until one winner is selected.

4.3. The groups will be equal in size unless the final number of participants of the campaign is not a multiple of 6, then the sixth group will be formed on the leftover principle.

5. PROCEDURE AND TERMS OF ACCEPTING A PRIZE IN THE CAMPAIGN

5.1. After a prize has been drawn we will contact the winner within 5 business days.

5.2. Prize money will be transferred to the personal account of the winning participant. These funds can be withdrawn without any restrictions.

5.3. You may not transfer a prize to a third party (otherwise it will be deemed a waiver of the prize).

5.4. You may opt to waive the prize by signing a written prize money waiver form.

5.5. By taking part in this TenkoFX advertising campaign you give your consent to the use by us of your personal information (full name, city/country of residence) and photo for advertising or other purposes.

5.6. By taking part in the campaign you give your consent to an interview with our representatives which we may use for advertising purposes.

5.7. We reserve the right to deny the prize to a participant if you have committed a fraudulent act and/or violated the terms of the campaign.

5.8. We will post all information about the time, terms and results of the campaign, any early termination and list of winners (stating their full names) on www.tenkofx.com.

5.9. We reserve the right to post additional information about the campaign on www.tenkofx.com.

6. ADDITIONAL PROVISIONS

6.1. The terms of the Campaign are subject to change without prior notice at any time, at our sole discretion, if posted on www.tenkofx.com.
